**REQUIRED COURSES**

The **Legal Update I** and **Legal Update II** courses are both required by the Texas Real Estate Commission for license renewal.

If your license renewal does not require the **Broker Responsibility Course**, you may take the course for 6 hours elective credit.

**PLEASE NOTE:** It is the responsibility of the licensee to make sure credit is reflecting on the TREC website with enough time for the provider to correct any technical errors that may occur during transmittal. TREC does not waive the \$200 deferred fee.

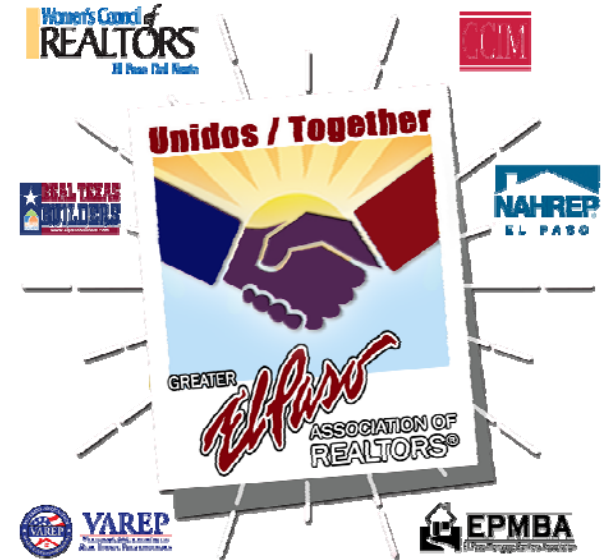
